FACILITES: Eight-lane, 25 yard pool equipped with non-turbulent lane lines, Starting blocks and electronic timing. Gates will open at 7:15am.

WARM UP: 7:30 a.m. **START TIME:** 8:30 a.m.

ELIGIBILITY: Swimmers must be current members of their swim club. Swimmer's age is determined as of June 30, 2017. Must be 9 years old & younger.

ENTRIES: Teams must submit their entries electronically using Hy-tek Team Manager or Team Unify entry files (via email to membership@brooksideswimclub.com)

- Events file for electronic entries will be available at brooksideswimclub.com under "Swim Team" & "Hosted Meets".
- **(Electronic entries must be followed by fee payment, entry summary form AND WAIVER within 72 hours.**
- **PLEASE DO NOT EXPECT TO PAY ENTRY FEES ON THE DAY OF THE MEET).**
- Swimmers may enter a maximum of **FOUR (4)** individual events and **two (2)** relays.
- No deck entries will be accepted.
- Please make every effort to **enter your swimmers with seed times**, so that all swimmers, in all heats, have a fair opportunity to be a heat winner.
 - **All electronic entries must be received by Thursday, July 6, 2017 @ 6:00pm at membership@brooksideswimclub.com**
- **ENTRY NAMES FOR THE PARENT EVENTS SHOULD BE SUBMITTED WITH YOUR ENTRIES, OR EMAILED PRIOR TO THE ENTRY DEADLINE. WE ENCOURAGE PARENT PARTICIPATION IN THE PARENTS' EVENTS. THE KIDS REALLY LOVE SEEING THEM SWIM. THE PARENT EVENTS DO NOT REQUIRE AN ENTRY FEE.**

TIMERS: Timers will be required from participating teams. We cannot run this meet without the help of our volunteer parents. Lanes and events will be assigned for each team **according to number of entries.** All teams must provide timers, No exceptions!

OFFICIALS: Officials will be requested from participating teams and may be required for teams with eight or more swimmers.

FORMAT: Timed Finals.

CHECK-IN: Coaches' check-in sheets will be provided in the coaches' packet and will be available upon arrival at the coaches table on the Brookside Pavilion. Swimmers should check in with their coaches as soon as they arrive, prior to entering the water.
Check-in sheets should be returned to the check-in table no later than 7:45 a.m.

AWARDS: Individual Events: Medals for 1st - 3rd places
Ribbons for 4th - 12th places
Relay Events: Medals for 1st - 3rd places
Ribbons for 4th - 6th places
Heat winners will receive gold fish coupon for pick-up of gold fish at end-of-meet.
All swimmers will receive a participant ribbon.
